Transportation:	Organizer will provide shuttle bus service from the Olympic village to the venue. Teams with their own cars should register these in advance during the accreditation process. Other Information:	Starting order for the team event will be in the same order as the results from the last EYOWF in Szczyrk 2009. Mixed teams (from 2 or more NOC's) cannot take part in the competition. Only one relay team per NOC.
Ceremonies:	After each competition there will be a flower cere- mony at the venue (best 6 athletes/teams). Medal ceremony (best 6 athletes/teams) will be organised in the Olympic Village – see general programme at www.eyowf2011.cz. Organiser can change the pro- gramme according to current weather conditions.
Storage / waxing:	There will be storage/waxing team cabins available for participating NOC teams in Cross country venue Vesec.
